CONDITIONS OF BOOKING: A Non-refundable Deposit of \$400 per person and a signed booking form is required at the time of booking. FINAL BALANCE - due 60 days prior to departure.

AMENDMENTS of confirmed arrangements – min. fee of \$25 per revision + any applicable charges.

LATE BOOKING FEE of up to \$100 may apply for bookings made within 30 days prior to departure.

CANCELLATION: Minimum fees are:

- Up to 60 days prior to departure: \$400 per person.
